Foreign representative vehicles

This bulletin contains current information about British Columbia's licensing program for vehicles owned or leased by foreign representatives and their offices.

Background

B.C.'s foreign representative licence plate (number plate) program is aligned with predominant practices in other Canadian jurisdictions and internationally. It is part of a package of privileges and benefits that reflect similar considerations extended by other countries to Canadian diplomatic and consular representatives abroad.

The distinctive foreign representative number plates with white lettering on a red background were first issued on June 11, 2007. Prior to that, only senior consular officers were issued special number plates, identified by the word "Consul" in blue letters on a white background.

Approximately 235 vehicles are actively licensed with BC foreign representative number plates.

Eligibility and mandatory features

Foreign representative vehicle licensing is mandated by the federal Department of Foreign Affairs, Trade and Development (Office of Protocol) for eligible vehicles owned or leased by individuals and other entities accredited by the Office of Protocol; although it is optional for Honorary Consular Officers (Canadian citizens residing in British Columbia representing a foreign country). For Honorary Consular Officers, the program is limited to one set of plates for one registered vehicle in their name.

Only passenger vehicles, commercial vehicles and motor homes are eligible. The initial licence issuance is through ICBC Autoplan Sales, subsequent transactions may be processed by Autoplan brokers.

The vehicle registration will show the name of the accredited party. This may be an accredited individual (for example, a foreign representative and their dependents, or an honorary consular officer), an International Organization, a Foreign State or Consular Post, an office of a political subdivision of a foreign state, or an Other Office (for example, the Taipei Economic and Cultural Office.)

Operation

Normal rules of the road for vehicle operations apply. There are no special restrictions on who may operate a foreign representative licensed vehicle, where, or for what purpose it may be operated.

Number plate prefixes

The number plates are in an AA ###A alpha-numeric format (the letters I, O, Q, S, U, Y and Z are excluded.) The first two alpha characters in the licence plate number correspond to one of five accreditation categories designated by the federal Office of Protocol, as follows:

- CC 000A for Career Consular Officer-level foreign representatives and their dependents or a Foreign State or a Consular Post where headed by a Career Officer;
- CS 000A for administrative, technical and service level foreign representatives and their dependents;
- DL 000A for diplomatic-level foreign representatives and their dependents or an International Organization;
- HC 000A for Honorary Consular Officer-level foreign representatives or a Consular Post headed by an Honorary Officer; and,
- SR 000A for foreign officials and their dependents from Offices of Political Subdivisions of Foreign States and from Other Offices, and for their Offices.

Sample images of the foreign representative number plates are attached.

Plate surrender

Within 30 days after the conclusion of a foreign representative's posting or appointment, the foreign representative licence plate must be returned to an ICBC Autoplan broker.
