

**EXTENSION AND AMENDMENT TO
TRAFFIC AND ROAD SAFETY LAW ENFORCEMENT FUNDING
MEMORANDUM OF UNDERSTANDING**

This AMENDING AGREEMENT is dated for reference March 23, 2018

WHEREAS

- A. ICBC and MPSSG entered into TRAFFIC AND ROAD SAFETY LAW ENFORCEMENT FUNDING MEMORANDUM OF UNDERSTANDING dated April 1 2017, with a term ending on March 31, 2018 (the "MOU").
- B. The MOU provided that it could be extended for an additional period of one year and amended provided that the parties agreed and the Chair of the Treasury Board approves.
- C. The parties have agreed to extend the term of the MOU to March 31, 2019 and to amend some of its terms effective as of the date of this Amending Agreement so that the provisions of this Amending Agreement apply to the extended term of the MOU.
- D. The Chair of the Treasury Board has approved the extension and amendments of the MOU as set out herein.

THEREFORE the parties agree as follows:

1. In this Amending Agreement, terms defined in the MOU will have the same meaning in this Amending Agreement and each of the following terms shall, unless the context otherwise requires, have the meaning set out beside it.

“Extended Term” means the term as set in paragraph 6 of this Amending Agreement.

2. All of the provisions of the MOU apply to the Extended Term and the MOU as extended and amended by this Amending Agreement is ratified and confirmed.
3. Paragraph 7 of the MOU is amended by adding the following subparagraph (b):

“(b) For the Fiscal Year 2018/2019, the sum of \$22,408,480 less the amount ICBC spends for the Fiscal Year on Publicity for the Program and for equipment and office space for the Integrated Traffic Camera Unit.”

4. Paragraph 9 of the MOU is deleted and replaced with the following:

“9. MPSSG will advise ICBC of the actual Program costs by providing financial management reports:

- a) for the 2017/18 Fiscal Year by September 15, 2018; and
- b) for the 2018/19 Fiscal Year by September 15, 2019.

If the Payments made by ICBC:

- c) for the 2017/18 Fiscal Year exceed the actual Program costs, MPSSG will deduct the difference from the September 30, 2018 installment; and
- d) for the 2018/19 Fiscal Year exceed the actual Program costs, MPSSG will reimburse ICBC the difference by September 30, 2019.”

5. Paragraph 18 of the MOU is amended by adding the following subparagraph (c):

“(c) after December 31, 2017, the Working Group will provide quarterly updates to the Governance Council on the roadmap and implementation plan listed in subparagraph (a).”

6. Despite the date this Amending Agreement is signed, the Extended Term of the MOU is for 12 months commencing as of April 1, 2018 and ending March 31, 2019.

The parties have caused this Amending Agreement to be signed by their duly authorized representatives as of the date first set out above.


